**A RESOLUTION FOR THE PURPOSE OF ACCEPTING THE RESIGNATION OF THE
COUNCIL MEMBER, BONNIE TEEL, AS COUNCIL MEMBER.**

Whereas, Council member, Bonnie Teel tendered her resignation from the elected office of council member and the appointed office of city treasurer, effective April 8, 2020; and

Whereas, an elected official may retract his or her resignation at any time before the council has voted to accept it; however, after the council has voted to accept the resignation, it may not be retracted. An elected official's resignation is not effective until it is accepted by a majority of the City Council; and

Whereas, it is the finding and conclusion of the City Council that accepting the resignation of Council Member Bonnie Teel is in the best interest of the City of The Highlands, Kansas, and Bonnie Teel.

**NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF
THE HIGHLANDS, KANSAS:**

Section 1. The City Council for the City of The Highlands, Kansas, hereby accepts the voluntary resignation of the position of Council member by Bonnie Teel on this 9th day of April, 2020.
